By signing below you acknowledge and agree that:

You are the owner or have the legal authority to sell the consigned item.

Sporthorse Saddlery will display the item in the store and include it in consignment saddles listed on our website. Sporthorse Saddlery will attempt to get the Desired Selling Price, and will not sell the item for less than the Minimum Selling Price without first contacting you and obtaining your permission.

If the item is found to be in poor or unsafe condition, or if the price you are asking for the item is too high for the condition/value of the item, Sporthorse Saddlery reserves the right to refuse to accept the item for consignment, or void this agreement if the discovery is made after the date of the consignment.

For their services in marketing the consigned item, Sporthorse Saddlery will retain a percentage of the selling price as a commission. You may choose one of two payment/commission plans at the time you consign your saddle or when it is sold. In either case, your "payment" will be available within 30 days after the date of the sale. Check the box below to indicate your choice:

- I would like to be paid by Check (Commission rate of 25%, You get 75%)**
- Please contact me when my saddle is sold, and I will decide then**

You agree to leave the item at Sporthorse Saddlery for ninety (90) days from the date on this agreement. **If you remove the saddle before the expiration of the 90 day period, you will incur a charge of \$50** to cover the costs Sporthorse Saddlery has incurred in its efforts to market/sell the saddle. _____ (Customer Initials)

If, after your saddle has been consigned for 12 months or more with minimal interest, Sporthorse Saddlery may decide to ask you to pick up the saddle. If we are unable to contact you by phone and/or email after 3 attempts (per information provided above), Sporthorse Saddlery has the right to donate or otherwise dispose of the saddle. _____ (Customer Initials)

If you ship your item to Sporthorse Saddlery or if you request that it be shipped elsewhere by Sporthorse Saddlery, you are responsible for all shipping charges, claims, or related issues.

Sporthorse Saddlery will use all conventional safeguards in the handling and displaying of consigned goods, however you understand that the consigned item is not insured by Sporthorse Saddlery, and that Sporthorse Saddlery is not responsible for any loss due to fire, theft or damage. You also agree to hold Sporthorse Saddlery free from any claims arising from the sale of this item now or at any time in the future.
