Sporthorse Saddlery Non-Saddle Consignment Agreement

To place items on Consignment:

Please schedule an appointment to bring your items to the store (Local consignment only at this time). Please bring the items cleaned, polished, conditioned and in show ready condition.

ITEMS ACCEPTED: High quality show and schooling apparel, equipment, and tack for dressage, eventing, hunters and jumpers with a starting consignment selling price of \$25 or more.

ITEMS <u>NOT</u> ACCEPTED: Helmets, dirty or smelly items, dry rotted leather, rusted metal or broken tack, used grooming tools, tall boots WITHOUT zippers, outdated clothing (wool show coats, show shirts with separate chokers, etc.) horse blankets, polo wraps, bandage wraps, quilts, chemicals or consumables.

Sporthorse Saddlery shall determine the acceptability of all items, and has the right to refuse or return any item(s) to the consigner.

Please read and initial each of the following terms:

- The consigner will receive 60% of the selling price as <u>STORE CREDIT ONLY</u> when each item is sold.
- By consigning with Sporthorse Saddlery the consigner agrees to leave their items for a Consignment Period of 90 days. The consignor is held responsible to keep track of the Consignment Period expiration date based on the date the items are dropped off.
- At the end of the Consignment Period, Sporthorse Saddlery will reduce the selling price by 25% and extend the contract for another 90 days. If after the 90 day extension the item(s) haven't sold, the consigner must pick up within <u>14 days</u> or Sporthorse Saddlery will donate items to a suitable charity.
- Merchandise removed before 90 days will incur a charge of \$5 per item.
- Sporthorse Saddlery will help determine pricing on all consigned items. If unable to price your items the day that they are dropped off, then Sporthorse will email you the prices they believe fair for your items. If you do not confirm or ask for price adjustments within 48 hours Sporthorse has permission to put the items on the floor at this price.
- Items are clean and in working condition without the need for fixes or replacements. All item(s) consigned are odor and stain free, and without any rust, rips or tears.
- Sold consignment items are configured at the end of each month. If your items have sold Sporthorse Saddlery will contact you by email with a description of items sold and the amount of store credit you will receive on your account.
- The consigner assumes all risks and agrees to bear any and all losses which may result from fire, theft or any other casualties while the merchandise is consigned at Sporthorse Saddlery.
